Mensona Kennel Club, Inc. Constitution and Bylaws Regarding Membership:

Article II, Section 3 Election to Membership: Prospects for membership are invited to attend two regular membership meetings within a six month period. At the third meeting, their application will be read and voted on by the membership present. The application shall carry the endorsement of two memberships, who shall be unrelated and from different households. Included with the application shall be payment to cover the year's dues. The application will be voted by secret ballot. Affirmative vote of 3/4 of the members present shall be required to elect applicant. Applicants who have been rejected may not apply again within six months after such rejection.

Article II, Section 4 Minimum Requirements for Continuing Active Members:

- A) attend two membership meetings per year, B) assist with show setup or work at an assigned job during the day of the show or C) participate in other club events and activities as approved by the Board of Directors.
